| Crasnow, Sharon & Kristen Internann: <i>Feminist Epistemology and Philosophy of Science</i> . An Introduction. – March 2024 (Routledge) | Feminist Epistemology and Philosophy of Science: An Introduction is structured around six questions and the answers to them that have been offered by feminist epistemologists and philosophers of science. By showing how these answers differ from those of traditional philosophical approaches, the book situates feminist work in relation to philosophy more generally. The questions are: Who knows? What do we have knowledge of? How do we know? What don't we know? Why does it matter? and How can we know better? In addressing these questions, the book reviews feminist accounts of objectivity, agnotology, issues in social epistemology—including epistemic injustice—and considers how feminist epistemology and philosophy of science aim at better knowledge production. The audience for the book is upper division undergraduates, but it will be useful as a foundation for graduate students and other philosophers who are seeking a general understanding of feminist work in these areas. |

| Dube, Musa W., Telesia K. Musili & Sylvia Owusu-Ansah (ed.): Gender, African Philosophies, and Concepts . – March 2024 (Routledge) | This volume sets out to explore, propose, and generate feminist theories based on African indigenous philosophies and concepts. It investigates specific philosophical and ethical concepts that emerge from African indigenous religions and considers their potential for providing feminist imagination for social justice-oriented earth communities. The contributions examine African indigenous concepts such as Ubuntu, ancestorhood, trickster discourse, Mupo, Akwaaba, Tukumbeng, Eziko, storytelling, and <i>Ngozi</i> . They look to deconstruct oppressive social categories of gender, class, ethnicity, race, colonialism, heteronormativity, and anthropocentricism. The book will be of interest to scholars of religion, philosophy, gender studies, and African studies. |

| Hultgren, Anna Kristine & Pejman Habibie (ed.): <i>Women in Scholarly Publishing</i> . A Gender Perspective . – September 2023 (Routledge) | Women in Scholarly Publishing explores the under-researched topic of gender and scholarly publishing. While often considered separately, the relationship between gender and scholarly publishing has been neglected. Bringing together experts across applied linguistics, this book brings to the fore the challenges and opportunities faced by female academics in both Anglophone and non-Anglophone contexts as they participate in the production and dissemination of knowledge. Contributors show how female scholars' production and dissemination of knowledge intersect with gendered structures and disciplinary cultures in complex ways. The key strands of work that this volume seeks to bring together include essentialism in gender studies and alternative perspectives on how gender should be viewed and studied in knowledge production and dissemination; the specific ways in which the labour and conditions surrounding scholarly publication are gendered or perceived as gendered; the examination of discourses, texts and genres from a gender perspective; and the continuing gendered and gendering impacts on career trajectories of women academics. While women's barriers are documented across geopolitical contexts, the book also shows how norms, policies and practices can be challenged and alternative futures imagined. |
| Goetz, Judith & Mayer, Stefanie (ed.): <i>Global Perspectives on Anti-Feminism.</i> Far-Right and Religious Attacks on Equality and Diversity." – September 2023 (Edinburgh University Press) | This new book brings together research and analyses from five continents in order to promote a global perspective on the thoroughly global phenomenon of the current culture wars around sex and gender. The contributions show how transnational networks spread discourses that were developed in the Global North, and how they become re-articulated in different national, political and religious contexts. In recent years, issues of gender and sexuality have become a political battlefield on which far- |

| | right, religious and conservative actors wage their war against liberal and left-wing ideas, as well as emancipatory movements. 'Anti-Gender' crusades, which had originally been launched by the Vatican, deeply impacted societies and politics especially as these discourses were adopted by the secular far-right. Campaigns against sexual and reproductive rights, against gender equality and sexual diversity were waged from Russia to the United States and from Latin America to Japan. |

| Krasny, Elke: "Living with an Infected Planet. Covid-19, Feminism, and the Global Frontline of Care." – May 2023 (transcript) | »We must declare war on the virus,« stated UN chief António Guterres on March 13, 2020, just two days after the WHO had characterized the outbreak of the novel Covid-19 virus as a pandemic. Elke Krasny introduces feminist worry in order then to develop a feminist cultural theory on pandemic frontline ontologies, which give rise to militarized care essentialism and forced heroism. Feminist hope is gained through the attentive reading of feminist recovery plans and their novel care feminism, with the latter's insistence that recovery from patriarchy is possible. |

" – 2024 (Routledge) | Drawing together the latest research on migration, gender, and COVID-19, this erudite Research Handbook contributes to a better understanding of the immediate and longer-term implications of the pandemic on gender dynamics and roles in international migration. Providing a wealth of expert critical analysis, it considers post-COVID-19 realities and assesses the future scope of research in this interdisciplinary field of study. Capturing multi-disciplinary insights and diverse geographies, the Research Handbook explores migration in all of its facets, from displacement and internal and international mobility to return migration and labour mobility. Chapters address topical issues relating to the policy and programmatic implications of the COVID-19 pandemic for migration and migrants from a gender perspective. Marie McAuliffe and Céline Bauloz, alongside leading researchers and academics, present a major contribution to scholarly inquiry which is crucial for informing inclusive and sustainable responses to improve migrants' wellbeing and protection. | Minkus, Lara: "Disentangling the Components of the Gender Wage Gap." – 2023 (Nomos Verlag) | This book examines the components of and driving forces behind the gender pay gap, focusing on Germany. It covers the historical significance and measurement of the gap and provides relevant theory and empirical evidence. It also explores three key areas, all related to the composition and forces that perpetuate the gender pay gap in today's labour markets. First, the impact of radical changes in political and economic institutions; second, the significance of occupations; and third, the impact of labour market discrimination and soft skills. The book concludes by summarising key findings, research needs and implications for the academic debate on this subject. |

| Nenic, Iva & Cirmardi, Linda (eds.): "Women's Leadership in Music. Modes, Legacies, Alliances." – March 2023 (transcript) | Various modes of women's contemporary cultural, social and political leadership can be found in music. Informed by different histories and culturally bound social mores but also by a comparative perspective, the contributors of this volume ask what can be considered leadership in culture from women's point of view. They deconstruct the notion of leadership as corporative and career-related modes of success by showing how women's agency, power and negotiation in and through music can and should be considered as empowering, transformative and role-modeling. By interweaving several disciplinary perspectives – from ethnomusicology, musicology and cultural management to sociology and anthropology – this volume aims to substantially contribute to the study of women's leadership. |
| Randall, Thomas: "Justice, Care und Value. A Values-Driven Theory of Care Ethics." – July 2023 (Routledge) | In <i>Justice, Care, and Value</i> Thomas Randall argues for the radical potential of care ethics as a distinct and preferable theory of distributive justice. Advancing the feminist literature, this book defends a vision of society that can best enable caring relations to flourish. Specifically, Randall proposes a values-driven theory of care ethics that derives normative criteria for evaluating the moral worth of caring relations and their surrounding institutions via a classification of the values of care. They argue that such a theory gives us unique and meaningful solutions to contemporary questions of distributive justice across personal, political, global, and intergenerational domains. In doing so, the book makes significant strides to engage care ethics with the broader moral and political philosophy literature. Topical and interdisciplinary, Randall demonstrates that care ethics has the conceptual resources to ground distributive theories of socialism, territorial and natural resource rights, obligations to future generations, and historic redress. The book will be of great interest to academics, researchers, and students of feminist philosophy, but also of liberalism, political |
